Reasonable trash removal, feedzone access and chairlift access will be provided. Each company will receive up to four (4) credentials (credential privileges will be outlined in your confirmation packet).

PAYMENT AND CANCELLATION POLICY

Full payment must accompany this contract to secure space assignment. Cancellations received at least eight (8) days prior to race will receive a full refund. No refund for cancellations received seven days or fewer, prior to 8/1/09. If you cancel within 7 days or leave early, subletting will not be allowed.

SPACE ASSIGNMENTS

When calculating "SPACE", include all necessary/occupied area, such as trailer tongues, swing-out or down doors, tailgates and ramps, outside perimeters or tent anchors, or any other occupied space. Space is assigned on a first come, first serve basis, working from the area closest to the start/finish and moving back.

Promoter reserves the right to relocate any space at any time for any reason.

INSURANCE

UNOCCUPIED SPACE

Management reserves the right, should any vendor's space remain unoccupied on Thursday, July 16, 2008, or should any space be forfeited due to failure to make proper payment to rent said space to any other vendor, or use said space in any other manner, but this clause shall not be construed as effecting the obligation of vendor to pay the full amount specified in his/her invoice for the rental, should management not resell the space.

OPERATION

Promoter reserves the right to restrict the Tech area to a maximum noise level and to acceptable methods of operation and display materials. If, for any reason, Promoter deems an exhibit objectionable, the exhibit will be subject to removal. Support staff will only be allowed to bring their vehicles down Main Street before 8:00am. This reservation includes persons, pets, conduct, printed matter, or any item of poor character which management in its sole discretion considers objectionable to the event's well being. In the event of eviction, management will not be liable for the refunding or rental fees.
