CONDITIONS OF ACCEPTANCE:

All products to be displayed are hand-crafted and the applicant's own creation. No imported product is allowed. Mount Snow reserves the right to remove, without refund or recourse, any exhibitor who misrepresents himself or his product.

PAYMENT AND CANCELLATION POLICY

Exhibitor's check and completed application represents commitment to the show. It is understood that if exhibitor cancels at any time after receipt of application, entire fee and space are forfeited. It is further understood that failure to appear for set-up one hour prior to show opening constitutes forfeiture of entire fee and space to show. Exhibitor will not sublet booth space nor act as a dealer/representative for any other craftsman. Full payment must accompany this contract to secure space assignment. It is the exhibitor's sole responsibility to obtain all tax, vendor, or other permits as required by local, state or federal authorities at their own expense.

SPACE ASSIGNMENTS

Spaces will be assigned based on a first come, first serve arrangement based on space. Not all vendors will be accepted.

UNOCCUPIED SPACE

Exhibitor will maintain booth in good order and **remain set up until closing each day**. Management reserves the right, should any exhibitor's space remain unoccupied, or should any space be forfeited due to failure to make proper payment, to rent said space to any other vendor, or to use said space in any other manner, but this clause shall not be construed as effecting the obligation of vendor to pay the full amount specified in his/her invoice for the rental should management not resell the space.

OPERATION

Exhibitor will abide by all rules and regulations of Mount Snow, Ltd. Mount Snow, Ltd. reserves the right to add or amend rules and regulations at any time and to make final interpretations of all rules. Any decision of Mount Snow, Ltd. shall be final. Promoter reserves the right to restrict the exhibit to a maximum noise level and to acceptable methods of operation and display materials. If for any reason, an exhibit is deemed objectionable by Promoter, the exhibit will be subject to removal. This reservation includes persons, pets, conduct, printed matter, or any item of poor character which management in its sole discretion considers objectionable to the event's well being. In the event of eviction, management will not be liable for the refunding of rental fees.

SECURITY

Management will employ night security and will take reasonable precaution to safeguard exhibitors' property, however, promoter recommends that exhibitors **remove all valuables or lock them up tightly upon closing**. Exhibitors will not hold Mount Snow, Ltd. or its agents, employees or officers liable for failure to perform or fulfill its contractual obligations provided such failure is caused, occasioned or impeded by conditions beyond its control. Nor will the exhibitor hold Mount Snow, Ltd. the location of the show, their respective agents, employees, or officers liable for any loss, damage, or injury to product, property, or person caused by products sold or exhibited by exhibitor directly or through warranty expressed or implied. Insurance for such loss, damage, or injury will be solely at exhibitor's expense.
