- I attest and verify that I am physically fit and sufficiently trained to participate in all activities associated with the program or event noted above. My participation in activities and events organized or sponsored by the National Off Road Bicycle Association is voluntary.
- I acknowledge that there are many INHERENT risks involved in being a volunteer for a mountain bike race including but not limited to: conditions of the premises, operation of the ski area and the mountain bike race, falls on steep, uneven and slippery terrain, collisions with man made objects, race participants and guests, actions or omissions of employees and agents of Mount Snow, and I therefore accept for myself the full responsibility for any and all such damage or injury of any kind which may result. I further agree that the phrase "inherent risks" means those risks, which are listed in this agreement, or those that can reasonably be inferred therefrom. I also agree that these risks are both obvious and necessary to my activities as a volunteer.
- I agree that this contract may also be plead as an affirmative defense to any claim that I might make as a result of any damage, injury, and/or death, which I may sustain as a result of my participation in and caused by the inherent risks of this voluntary activity.
- I promise not to sue Mount Snow Ltd., its owners, affiliates, agents, employees and sponsors (Mount Snow) as I accept all risks associated with my participation in activities and events organized or sponsored by Mount Snow and the National Off Road Bicycle Association, including those that could result in injuries or illness to person and damage or loss to property as I hereby indemnify and hold harmless Mount Snow from such claims.
- In the event that I am unable to do so on my own because of an injury, I consent to administration of first aid and other medical treatment and agree to pay the costs of any such treatment.
- I agree that any suit or legal action against Mount Snow Ltd., its owners, employees and agents shall be brought only in the State or Federal Courts having jurisdiction in the state of Vermont and shall be governed by Vermont Law and that no claims or actions shall be brought in any other jurisdiction,.
- If any portion of this document is determined to be unenforceable all other parts shall remain in full force and effect. I agree that the contents of this document shall be binding upon my heirs and assigns.
